Nebraska Fuel Tax Rate

The fourth quarter 2015 fuel rate (October 1, 2015 through December 31, 2015) is .2610 cents. The rate for the first quarter 2016 (January 1, 2016 through March 31, 2016) will be .2680.

Prepaid Fuel Receipts

If a driver prepays for fuel at the pump, they must ask the vendor for a fuel receipt listing the actual gallons purchased. The original receipt issued at the pump will typically only list the total prepaid dollar amount, and is not acceptable for tax-paid credit in an audit.

IFTA, IRP and UCR Renewals

Do not delay in filing your 2016 renewals. The IRP grace period (January 1 through January 31) and the IFTA grace period (January 1 through February 29) are for carriers who have paid for their 2016 credentials and need time getting the new credentials in the trucks.

Make sure your renewal is in the office and paid so you are guaranteed credentials by the start of the enforcement dates:

UCR – January 1, 2016 (no credential is issued) IRP – February 1, 2016 IFTA – March 1, 2016
