Nebraska Fuel Tax Rate

The third quarter 2016 fuel rate (July 1, 2016 through September 30, 2016) is .2580 cents. The rate for the fourth quarter 2016 (October 1, 2016 through December 31, 2016) will be .2580 cents.

Renewal Time

The IFTA, IRP and UCR renewals have been mailed. We encourage eligible carriers to renew their IFTA and IRP credentials on-line at www.clickdmv.ne.gov. On-line filing for IRP is available October 1st thru January 31st. IFTA on-line filing is available October 1st thru February 28th. UCR renewals can be renewed on-line at www.ucr.in.gov and is available beginning October 1st. The UCR site is a national site not maintained by Nebraska.

Beginning January 1, 2017, you will be unable to use the on-line IFTA renewal if you haven't processed your fourth quarter 2016 return. This is also true if you have any delinquent filings.

Bulk Fuel Records

If any IFTA units fuel from a bulk fuel tank, detailed records must be maintained:

- 1. Withdrawal Logs:
 - These must list the date, unit number, and number of gallons for each bulk withdrawal. Bulk withdrawals must be recorded for all units and equipment using the bulk tank (IFTA and non-IFTA).
- 2. Inventory Reconciliations:
 - A quarterly reconciliation must be prepared that lists:
 - a. Gallons of fuel in the bulk tank at the beginning of the quarter (Beginning inventory)
 - b. Tax-paid bulk fuel purchases made during the quarter
 - c. Total gallons of fuel withdrawn from the bulk tank during the quarter (this amount should come from the bulk withdrawal logs)
 - d. Gallons of fuel in the bulk tank at the end of the quarter (Ending inventory)
- 3. Tax-Paid Bulk Fuel Purchase Receipts:

These fuel receipts must contain the same information that is required for over-the-road fuel receipts, except for the unit number.

This information must be maintained for each bulk fuel tank that is used by one or more IFTA units. The bulk tank must have a reliable meter for recording bulk withdrawals to be acceptable for IFTA purposes
