Nebraska Fuel Tax Rate

The fourth quarter 2018 fuel rate (October 1, 2018 through December 31, 2018) is \$0.28. The rate for the first quarter 2019 (January 1, 2019 through March 31, 2019) has not been published as of the printing of this newsletter.

Unified Carrier Registration (UCR) - 2019 Renewal

The 2019 UCR fees have not been approved as of the printing of this newsletter. Once approved, our office will mail a postcard to all carriers with an active Interstate DOT number with instruction on how to file.

Make a note on your calendar of the due dates to file your quarterly returns for registration year 2019. As a reminder, all returns must be filed timely to avoid the penalty of \$50.00 or 10 percent of the tax, whichever is greater.
