### NEBRASKA FUEL TAX RATE

The first quarter 2022 (January 1, 2022 through March 31, 2022) fuel rate is \$0.2480. The rate for the second quarter 2022 (April 1, 2022 through June 30, 2022) will be \$0.2480.

#### ARE YOU REPORTING IFTA MILES FOR AN OWNER/OPERATOR?

We have many IRP account holders in which the IFTA reporting is done by a different entity. If you are one of the entities reporting IFTA miles for a driver that owns his own truck and IRP credentials, make sure you are communicating with them to keep a copy of the miles reported to you. They need the miles to renew their IRP credentials.

#### FROM THE AUDIT DESK

#### **Portable GPS Devices**

Using a portable GPS device to record the miles for IFTA & IRP is not an acceptable method by itself. A portable GPS may show odometer readings, but these are just calculated from the GPS miles (not actual odometer readings from the truck's dashboard or ECM). As a result, if you choose to use a portable GPS device for IFTA & IRP, the driver must also manually record the actual beginning & ending odometer readings for each day or trip on a trip sheet or similar record. You can still use the portable GPS to calculate the daily or trip miles per state but must then balance these miles to equal the total odometer miles for each day or trip. Lastly, if you are unable to save or print the detailed origin/destination information for each day or trip from the portable GPS device, the driver would also have to record this information on a separate record.
