NEBRASKA FUEL TAX RATE

The first quarter 2023 (January 1, 2023 through March 31, 2023) fuel rate is \$0.29. The rate for the second quarter 2023 (April 1, 2023 through June 30, 2023) will be \$0.29.

GEORGIA SPLIT RATE

Georgia continued their tax holiday on all motor fuels through January 10, 2023. Travel and gallons purchased from January 1 through January 10 will be reported on the first line of the first quarter return. Travel and fuel purchased beginning January 11 will be included on the second line.

FROM THE AUDIT DESK

GPS RECORDS RETENTION

Mileage information required for GPS must be retained for 5 years. You should verify with your GPS provider how long they retain this information or make it available. If it is not retained and/or made available for 5 years, you will need to save the GPS information yourself on a monthly or quarterly basis. The GPS information that would need to be provided for an audit is:

- a. A report containing the unedited, raw GPS data. This would include a line of data for each time the GPS sends a signal or "ping", and include at minimum: date & time, latitude & longitude, location (usually an address with the nearest city & state), odometer reading, and the total miles between each GPS signal. This report must be downloaded into Excel or CSV format.
- b. A second report would need to contain the miles per state and total miles for each day, and for the quarter. The quarterly report would be your quarterly miles summary. Make sure total mile's equal total odometer miles for each unit in each quarter.
