NEBRASKA FUEL TAX RATE

The fourth quarter 2023 (October 1, 2023 through December 31, 2023) fuel rate is \$0.29. The rate for the first quarter 2024 (January 1, 2024 through March 31, 2024) will be \$0.291.

GEORGIA SPLIT RATE

Georgia extended the temporary suspension of motor fuel tax through November 29, 2023. For the fourth quarter filing, if you purchased fuel from October 1, 2023, through November 29, 2023, you did not pay fuel tax at the pump,

The first line on the schedule is for travel from October 1st through November 29th. The second line is for travel from November 30th through December 31st. For any fuel purchased during the suspension of tax, enter the fuel in the Other Travel line under column E, Tax Paid Gallons.

To calculate the appropriate Average Miles per Gallon (AMG), all miles and gallons must be recorded on the return.

2024 RENEWAL CREDENTIALS

Carriers who have renewed the IRP and IFTA credentials for registration year 2024 are able to run on the grace period for both programs with their 2023 credentials.

UCR Enforcement begins January 1, 2024

IRP Enforcement begins February 1, 2024

IFTA Enforcement begins March 1, 2024

We offer on-line services for both IRP and IFTA renewals. Log into our system at https://nebraska.gov/services. Online processing for both programs will end March 31, 2024. You are subject to citation by law enforcement if you are unable to display the renewal credentials by the enforcement dates.
